The papers of William Oliver were deposited in the Archives of Labor and Urban Affairs in 1963.

William H. Oliver was born in 1915 in Chattanooga, Tennessee, where he attended public school and later graduated from Tennessee State College. He served as assistant editor of the *Chattanooga World* prior to moving to Detroit in 1937. In 1941, Oliver became the first African American to serve on the executive board of UAW Ford Local 400. He became a staff member of the International in 1945 and since 1946, has served as co-director of the Fair Practices and Anti-Discrimination Department with UAW President Walter Reuther.

Part 2 of the William Oliver Collection contains correspondence, reports, minutes and meeting notes reflecting Mr. Oliver's involvement with the NAACP throughout the 1970s and 1980s as an NAACP vice-president and as president of the organization's National Housing Corporation, created in 1971. Also included are records of his activities during the late 1950s and early 1960s with the Sunnyhills Cooperative, an integrated, low-income housing community set up under the auspices of the UAW Fair Practices Department. After Walter Reuther's death in 1970, Leonard Woodcock named William Oliver sole director of the UAW Fair Practices Department. Mr. Oliver died in Detroit, Michigan on May 30, 1994.
