The papers of W. Ellison Chalmers were placed in the Archives of Labor and Urban Affairs in June of 1965 by Mr. Chalmers. Additional papers were deposited in August of 1983.

Born in Brooklyn, New York, February 21, 1903, William Ellison Chalmers received a B.A. from Brown University in 1925 and a Ph.D. from the University of Wisconsin in 1933. While studying at the University of Wisconsin, he worked with John R. Commons lobbying for various bills in the state Legislature. Chalmers taught briefly at the University of Pittsburgh (1928-30). He received a Social Science Research Fellowship in 1933 and a Wertheim Fellowship the following year. While on the Wertheim Fellowship, he began writing his auto study manuscript and worked closely with the AFL in Detroit. Chalmers worked for the federal government from 1934 to 1947, serving as a delegate to the International Labor Organization (ILO) in 1935, after which he became a professor of economics at the University of Illinois.
