The papers of Mary Wheeler were deposited with the Labor History Archives in February, 1970 by Miss Wheeler.

Mary Wheeler was a teacher at Proviso High School in Maywood, Illinois, and a member of Local 571, American Federation of Teachers, from its inception. In 1938, she was relieved of her teaching position presumably because of union activities, and union negotiations brought about her re-instatement. She served as president and executive secretary of West Suburban Teachers Union (Local 571), chairman of the bargaining committee and of the executive committee. She served also as a vice-president of the American Federation of Teachers and was president of the AFT Boca Raton Residence Corp. Inc.

The Mary Wheeler Collection covers the period from 1938 to 1967.
