The papers of Stuart Strachan were placed in the Archives of Labor History and Urban Affairs in June of 1972 by Mr. Strachan and were opened for research in 1974.

Stuart Strachan was a supporter of Homer Martin during the factional disputes within the UAW in 1939. During his career Mr. Strachan held positions in UAW Local 615 and UAW Local 174.

Mr. Strachan represented the Cadillac Division of the West Side Local 174 at the General Motors National Conference on June 5 and 6, 1937 and served as a member of the Wage and Hour Committee. Stuart Strachan also represented Local 174 at the Milwaukee Convention in August of 1937 where he served as a member of the Committee of 17.

Stuart Strachan served as Vice President of the Executive Board of Local 615. He was an alternate to the General Motors Council on January 20 and 21, 1940 from Local 615. In addition, Mr. Strachan was a member of the Organization Committee of Local 615 United Automobile Workers of America (U.A.W.A.)-A.F.L.
