The papers of Richard Reist were placed in the Archives of Labor and Urban Affairs in October of 1974 by Mr. Reist and were opened for research in March of 1984.

Mr. Reist, born in 1928, received his B.S. and M.S. degrees at Michigan State University. He became a classroom teacher in the Lansing school system and from 1955 to 1964 he was a member of the Lansing School Employees, Inc., (an independent classroom teachers union), holding the offices of vice-president, treasurer and a member of the Board of Directors. In 1965 AFT Local 1620, also known as the Lansing Federation of Teachers, was organized and Mr. Reist, a charter member, held the office of vice-president and subsequently treasurer and publications chairman. In May of 1966 he was elected a vice-president of the Michigan Federation of Teachers and was chairman of the Legislation Committee of that organization.

The papers of Richard Reist reflect local and statewide efforts to unionize teachers in order to raise salaries, gain fringe benefits, and improve working conditions. There is also information concerning the union's interest in legislation relating to education and to court cases regarding the union's defense of tenure and to unfair labor practices.
