## THE HARLEY B. HISCOX COLLECTION

The papers of Harvey B. Hiscox were placed in the Archives of Labor and Urban Affairs in January and March of 1985 by Maureen Petra's and were opened for research in May of 1985.

Harley B. His Cox was born in Glendale, California. His college majors were religion, counseling and guidance. After graduation he served as part-time pastor and taught school. From 1961 through 1980 he held various offices in the American Federation of Teachers in California, Colorado and Texas. (The collection does not include papers from 1961-1967.) His important activities included organizing, bargaining agents elections and negotiations.

Mr. Hiscox helped found 100 locals in California, and during his three years in Colorado the individual membership almost doubled. In 1974 Mr. His Cox was asked by the national office to head a full-time organizing staff that was establishing in Texas, were the active membership was only 297. By 1978 it had increased tenfold.

In 1977 Mr. Hiscox became greatly concerned over the situation in Dallas. Seeing the potential for a strong organization in that city, he resigned his post as State Director of Organization and devoted himself entirely to Dallas. He gained national attention by leading a picket line in front of the governor's mansion to protest Gove nor William p. Clements' proposed cut in funds for public education.

In addition to his administrative work in three states, Mr. Hiscox was also editor of the <u>California Teacher</u>, and the <u>Colorado Teacher</u>, and several Texas newsletters. In 1980 he was awarded special commendation by the Union Teacher Press for the <u>Dallas Teacher</u>. Also, while in Colorado Mr. Hiscox was temporarily director of labor publications for the Colorado Labor Council, AFL-CIO.

Maureen Hiscox was Closely associated with her husband's work, and some of her papers are also included in the collection. In California she was office coordinator for her husband and director of offices services in Colorado. She served as photographer for the <u>Colorado Teacher</u> and as press secretary and public relations consultant for the Colorado Labor Council, AFL-CIO. She served as state representive of the AFL for both Colorado and Texas.

Important subjects covered in the collection are:

Dallas Local, No. 2260 Denver Classroom Teachers and the Colorado Federation of Teachers; Unity Drive His Cox's California Resignation Organizing; California, Colorado and Texas Picketing Gove nor Clements' mansion. Among the important correspondents are:
