#### **History**

Milton Tambor was born in New York City in 1938. He earned a Hebrew Teachers degree from Yeshiva University in 1957. He completed his bachelor's in Psychology at Wayne State University in 1959. Working for the Jewish Community Center of Metropolitan Detroit, he went on to earn his Master of Social Work degree from Wayne State in 1963. His thesis focused on the history of the Detroit Jewish Community Center.

He worked as Center Director at the UAW Retired Workers Center in Detroit 1964-1969. He then became president of Detroit AFSCME Local 1640, Community and Social Agency Employees, a post he held until 1978. As Local 1640 president, he acted as chief union negotiator in bargaining with 30 community agency employers. During his tenure, union membership more than tripled from 300 to 1000 members. He and Local 1640 were honored by a Detroit City Resolution and Mayor's Proclamation in 1978. During this period, he also served as Executive Board Member of the Metropolitan Detroit AFL-CIO and as Executive Vice President of Michigan AFSCME Council 77. From 1978 until 1981, he worked with Michigan AFSCME Council 25 as education coordinator. From 1981 to 1998, he served as Staff Representative in Council 25, and in 1998 and 1999 he assumed the positions of Council 25 Assistant Education Director and Senior Staff. Tambor served one term as president of the staff union, Professional Representatives Organization, and also chaired Council 25's strategic planning committee.

While working for AFSCME representing social workers, Tambor continued his scholarly efforts. During the 1970s, he taught at local universities. He served as a fieldwork instructor, supervising social work students from the University of Michigan and Wayne State University Schools of Social Work. Tambor also taught classes in sociology, collective bargaining, steward training, union administration, and contemporary labor problems at the Institute of Labor and Industrial Relations at University of Michigan-Wayne State University and at the Weekend College at Wayne State's College of Lifelong Learning.

Tambor returned to Wayne State University as a student to pursue a PhD in Sociology, which he earned in 1991, writing his dissertation on bargaining with non-profit agencies. He stayed on at the Wayne State School of Social Work as an associate member of the graduate faculty 1992-1998. His scholarly work focused on labor, social work, and non-profit agencies.

Throughout his career, Tambor was also involved in other labor and leftist organizations in Detroit, most notably as Co-chair of the anti-Vietnam War group Detroit Coalition to End the War Now, Chair of the Michigan Labor Committee on Central America, and activist with the New American Movement which merged with the Democratic Socialist Organizing Committee to form the Democratic Socialists of America.

In 2001, Tambor retired and moved to Atlanta. In 2005, he formed and chairs the Metropolitan Atlanta Democratic Socialists of America local. He has also been active as Co-chair of the Atlanta Fighting Foreclosure Coalition and as treasurer of the newly constituted Atlanta Jobs with Justice. At the US Social Forum in Atlanta in 2007 and in Detroit in 2010, he made presentations on working class/socialist perspectives and fighting foreclosures.

#### [17] Scope and Content

The Milton Tambor Papers document Tambor's academic career, work for AFSCME, and participation in labor, leftist, and progressive organizations in Detroit. They include articles, newspaper clippings, publications, fliers, meeting minutes, reports, and training material.

## Series I: Milton Tambor Writings, 1961-1995

This series contains information on Tambor's time with the Michigan Labor Committee on Central America. It also contains information about the work of the AFL-CIO's American Institute for Free Labor Development (AIFLD) primarily in Central America. Articles, reports, and publications appear.

# Series V: Detroit Leftist Organizations, 1968-1981

This series contains information about a variety of Detroit Leftist Organizations, especially the Detroit Coalition to End the War, the Motor City Labor League, and the New American Movement (NAM) in Detroit. Articles, reports, manifestoes, publications, and fliers appear.
