Abstract:	<p>William Gernaey was born in Detroit, Michigan on February 27, 1903. He attended the University of Michigan from 1920-1923 and majored in political economics. From there he studied one year each of business administration and accounting at Detroit Business University. From 1923 to 1927 Gernaey was employed by the Chrysler Corporation Detroit, as an industrial efficiency expert. From there he transitioned to investigating communist activities as an operative from 1927 to 1936. As a part of these investigations he was a member of the Youth Communist League and through his involvement in the group advanced to district secretariat and member of the Central Committee. He eventually became the section organizer of the North Detroit and Hamtramck sections of the party. In 1937 Gernaey started working for the Ford Motor Company. Here he established and organized an office on subversive activities where he investigated communist and pro-Axis Ford employees. After the attack on Pearl Harbor, he was authorized by his supervisor at Ford, to be a liaison to the FBI, both State and the City of Detroit Police, and Navy and Army intelligence.</p>
