Local 889, UAW, is an amalgamated white collar local serving Chrysler plants and Chrysler's suppliers in southeastern Michigan. The primary Units featured in this collection are Amplex, Auto Equipment Co., Hudson Sales, Kaiser—Frazer, King-Seeley, Tank Plant, Jefferson-Kerchival, Dodge Main, Marysville Parts, Mopar, Dodge Truck, John R-Highland Park.

The amalgamated union was established in 1940 and has served Chrysler-related plant continually.

The Local 889 Collection covers the period from 1943 to 1965.
