The Detroit Federation of Teachers (DFT) Local 231, AFT, AFL-CIO was founded in 1931. In 1938-1940, the DFT won a restoration of depression pay cuts, ten days sick leave, a ten-month school year, and class size reduction from fifty or more students to less than forty. The DFT was voted the sole bargaining agent by a majority of teachers in 1964. In 1965 the union signed its first comprehensive contract with the Detroit Board of Education under new state legislation. Additional files related to the DFT may be found in The Arthur Elder-Detroit Federation of Teachers Collection and The DFT WSU Chapter (AFT Local 231) Collection.

The papers of AFT: Detroit Local 231 consist of union newspapers, correspondence, reports, constitutions, convention material, proceedings, minutes, flyers, memos, brochures, newsletters, clippings, and legal documents related to the DFT, the Michigan Federation of Teachers, the AFT, the Detroit Board of Education, and the National Education Association.
