The papers of Local No. 53, United Automobile, Aircraft, and Agricultural Implement Workers of America (AFL-CIO) were placed in the Archives of Labor History and Urban Affairs, Wayne State University, Detroit, Michigan on August 1967 by Carl Shier, International Representative, Region 4, UAW.

As the result of a National Labor Relations Board (NLRB) sponsored election, Local 53 replaced Federal Local 23628 on 15 May 1958 as the union representing the workers at Automatic Division of Yale and Towne Industries. Local 53 adopted an active role in company-worker relations contrary to previous policies of Local 23628. The Union maintained this militant stance throughout the period covered by these papers.

The papers of Local 53 deal primarily with contract negotiations between the local and Automatic Division and with grievances from their inception to their resolution. The papers also demonstrate an evolution of grievance procedures especially for the period 1958-1962. To a lesser degree, these papers cover some inter-union activities. The collection spans the period from 1957 to 1968, however, most of the material concerns the years 1958 to 1964.

Important subjects covered in the collection are:

Contract negotiations and strike, 1958-1959 Wage reopener, 1959-1960 Contract negotiations, 1964 Grievances and development of grievance procedures, 1958-1968

Series I, Contract Negotiations, Boxes 1-3

Internal union planning notes, company positions, union positions, leaflets, job manuals, strike information and various other materials related to contract negotiations between Local 53 and Automatic Division between 1958-1965. There are also a few items concerning other UAW Locals negotiating with Yale and Towne and later Eaton, Yale and Towne.

Series II, Grievances, Boxes 3-4

Grievance records, union investigations, arbitration and mediation briefs, company exhibits, union exhibits, grievance procedures and some other materials related to settling grievances between the local and Automatic Division between 1958-1968.

Series III, Other, Box 4

Inter-Union activities, leaflet files, Region 4 financial reports for the years 1964-1965, Local 53 election procedure proposals and some material related to the formation of Local 53 comprise this series. This series spans the entire period from 1957-1968.

Internal union planning notes, correspondence, issues, company and union positions, strike materials for 1958-1959, leaflets, health plans, job manual, supplemental unemployment benefits plan, and various other materials connected with contract negotiations. The files are arranged alphabetically by topic or type of material and cover the period of September, 1958 "to August, 1965. Some materials are missing, e.g., the negotiators for Automatic state that the principle issues in the 1958-1959 contract talks are the union shop and cost of living escalators, yet there is no information on the union side to indicate this is so.
