History

Each airline in ALPA is represented by a Master Executive Council (MEC), this council is made up of representatives from Local Executive Councils (LEC) which are located at each of the airline's hubs. Through ALPA, and in compliance with the constitution and by-laws, the MEC is the administrative and decision making body for ALPA on their airline. Through its committees, the MEC negotiates contracts with the airline, processes grievances and legal action, ensures airline compliance with safety measures and regulations, as well oversees retirement issues, strikes, assessments, training, mergers, and any other pilot issues. Each MEC is headed by an elected chairman, vice-chairman, and secretary/treasurer. The Eastern Airlines (EAL) MEC was located in Miami and served EAL pilots from the beginning of ALPA until Eastern ceased operations in 1991.

Part 2 of the EAL MEC Records spans 30 years but focuses mainly on the last decade of Eastern's operations. The 1980s was a period of much strife for EAL, labor-management relations were poor and each side became more hardened towards the other as the decade progressed, eventually leading to the 1989 ALPA sympathy strike of EAL. During that decade the MEC set up programs to protect their pilots, such as Max Safety, which sought to bring the poor safety conditions, pencil whipping, and violations of FAA regulations under which they were being forced to fly to public attention. Because of the efforts of Max Safety these issues came under public scrutiny and put Eastern under an FAA investigation. When the MEC voted to honor the IAM strike in 1989, it initiated observation, tracking, picketing, and family awareness programs and successfully petitioned ALPA national for an association-wide assessment for strike benefits to support their pilots. The MEC also pursued litigation, worked with potential buyers, and participated in cross-union solutions to the problem of ownership of EAL during bankruptcy. After the strike was ended, the MEC negotiated for back to work arrangements for the few jobs that remained on the downsized carrier, and continuing training for out of work pilots. EAL ceased operations in January of 1991, and the MEC stopped functioning at the end of that year after instituting merger and fragmentation policies to ensure as many pilots as possible had airline work.

Scope and Content

Part 2 of the EAL MEC Records contains meeting minutes, correspondence, general files, committee files, and alphabetical files for the office. Most of the material spans the tenures of the last two chairmen to serve Eastern, Jack Bavis (1986-1989) and Skip Copeland (1989-1991). MEC meetings are documented through agendas, minutes, and resolutions from 1976-1991. Projects the MEC focused on can be seen in the committee and alphabetical files. The 1989 sympathy strike is covered through correspondence, faxes, articles, subject files, and bankruptcy litigation.
