The papers of UAW Local 1444 were deposited in the Archives of Labor and Urban Affairs in January 1997. UAW Local 1444 represented the workers at the Anaconda Wire and Cable Co. in Anderson Indiana. Anaconda was a supplier of insulated electrical wire products to the auto industry. Originally chartered in 1937 as Federal Labor Union Local 18704, the local re-organized in 1966 as UAW Local 1444 and was defunct in 1977.

The papers of UAW Local 1444 reflect the importance of the early organization efforts by the UAW in the auto industry. The papers contain the minutes of the earliest meetings of the FLU Local 18704 before Anaconda Wire and Cable recognized the local as the representative for collective bargaining. The papers of UAW Local 1444 also contain the minute books of the Executive Committee for 1936 and 1937 during which time one of the earliest sit-down strikes occurred at the General Motors Guide Lamp Division. 1
