The records of UAW Local 879 were deposited in the Archives of Labor and Urban Affairs in October of 1974 and were opened for research in July of 1986.

UAW Local 879 represents workers at the Twin City Ford Motor Company plant in St. Paul, Minnesota. It was chartered in 1941 following the recognition of the UAW by the Ford Motor Company. During the late 1940's and the 1950's, Local 879 participated in the Minnesota State CIO Farm Labor Relations Program. To demonstrate the relationship between farmers and labor, Local 879 and other CIO-affiliated unions set up booths and other displays at various Minnesota county fairs.

The papers of Local 879 reflect the daily functioning of the local, including its negotiations with Ford Motor Company. Also represented in the collection is Local 879's participation in state and local CIO and AFL-CIO industrial union councils and political action committees.
