The records of the SEIU International Executive Board were placed in the Archives of Labor and Urban Affairs in September of 1997 by SEIU and opened for research in August of 2003.

Subject to action of the international convention, the Executive Board is the final authority and the highest governing body of the union. It hears and rules on appeals of affiliates and their members or officers, protects the rights and privileges of its members, adopts, repeals and amends policies and procedures for the union, establishes and approves financial transactions, decides questions of jurisdiction, takes legal action to protect or otherwise advance the interests of the union, invests the funds of the International union for the benefit of the union and its members, buys, rents, leases, or disposes of property, comments on matters of national and international consequence, considers and pursues affiliations between SEIU and other organizations or bodies, and generally guides, manages and directs the activities and affairs of the union and its affiliates. The Board holds periodic meetings to discuss matters of importance as outlined above. In 1972, the General Executive Board (G.E.B.) changed its name to the International Executive Board (I.E.B.), although its duties and responsibilities remained essentially the same.

The Service Employees International Union has been a continuously existing international union since 1921. In its initial years it primarily organized janitors, window washers and elevator operators. Later it would extend its base of membership to include a wide range of public employees, healthcare workers, stadium workers, security guards, amongst many others. In 2003 its membership exceeded 1.5 million. The records of the I.E.B. reflect many of the changes of the union from 1921 until 1996.

This collection includes meeting minutes, reports, agenda, correspondence, notes, and other material related to the activities and concerns of the International Executive Board.
