The Utica Federation of Teachers Local 1448 records consist of materials that describe beginning stages of this local in Southeast Michigan in the early 1960s and trying to gain a presence in the Utica school district to challenge the Utica Education Association to represent teachers. Files pertaining to the AFT convention document the opposition within the AFT concerning the sitting president David Selden.
