The papers of Sol Dann were placed in the Archives of Labor History and Urban Affairs in July of 1970 by Mr. Dann and were opened for research in January of 1973.

Sol Dann was born in Detroit on May 14, 1903. After graduation from the Detroit College of Law he practiced law in Detroit from 1924 until his retirement in 1970.

Mr. Dann maintained a life-long interest in civil rights, freedom movements, and the protection of the rights of stockholders. He was active on behalf of Israel and the rights of the Jews to a Palestinian homeland. He served as one of the attorneys appealing Jack Ruby's conviction for the murder of Lee Harvey Oswald. Mr. Dann's interest in the rights of stockholders led him to initiate several proxy fights and lawsuits against both Studebaker-Packard Corporation and Chrysler Corporation. The bulk of the collection reflects Dann's stockholder activities, principally the Chrysler litigations.

Materials relating to the stockholders suits, including appeals and related collateral suits, against Chrysler Corporation and several of its officers and directors charging mismanagement and conflict of interest. The series covers the period 1956-1968, primarily 1960-1966.

The materials cover the period 1960-1964 and are arranged alphabetically by name of individual, company, or topic.

Legal documents (briefs, affidavits, motions, transcripts, opinions, and other documents) and incidental correspondence and notes relating to more than fifteen lawsuits and appeals dealing with conflict of interest, mismanagement, libel and slander, proxy solicitation, Chrysler's stock option plan, and the Courts' allocation of fees to attorneys. Although most of the suits were initiated in 1960 and 1961, appeals and fee petitions continued until 1966. The cases are chronologically arranged, with an alphabetical arrangement (Chrysler vs. Dann, Dann vs. Chrysler, Newberg vs. Chrysler, S.E.C. vs. Dann, etc.) for each year.
