Boaz Siegel was a faculty member of the Wayne State University Law School for over 30 years. He served as Acting Secretary of the Faculty Affairs Committee of the University Council beginning in 1949, succeeding the former secretary, Chairman R.J. Noer. During his career, Siegel served as a labor educator and school teacher and as a labor lawyer, including work with the UAW, especially in the

development of its benefits program. Siegel also spent some years in private law practice. He died in 2002.
