The papers of Edward McFarland were opened for research in March 1975.

Edward Wills McFarland was born in Millwood, Pennsylvania in 1885. He received his early education in that state, graduating from the Pennsylvania State Teachers College at Indiana in 1908. After teaching in Pennsylvania he moved to this state to attend the University of Michigan. He received his bachelor's and master's degrees in 1913 and 1915 respectively, and approximately two decades later, earned a doctorate degree, all from Michigan. His Special areas of interest were public finance, taxation, purchasing and distribution.

Between 1915 and 1920 McFarland taught in Detroit's Northern and Central high schools. In 1920 he was appointed to the Detroit Teachers College, eventually becoming professor of sociology and economics. He was one of the most important faculty members, quickly becoming popular among teachers in the city, who elected him president of the Detroit Teachers Association from 1932 to 1936.

McFarland served on innumerable committees for both mayors of Detroit and governors of Michigan. In 1937 he was appointed chairman of the Michigan Liquor Control Commission. He was an unsuccessful candidate for Congress in the Democratic primary of 1942. He was deeply involved in consumer affairs, being particularly interested in cooperatives and credit unions. He helped found the Motor City Co-op and the Detroit Teachers Credit Union.

Professor McFarland was an important figure in the creation of the labor education program at Wayne, and was placed in charge of the program in November, 1944. He continued his involvement in the program until his sudden death in December, 1949.

The papers of Edward McFarland deal in large measure with his involvement in the labor program. They also reflect, however, his concern with consumer issues and his political interests. Important subjects covered in the collection are:
