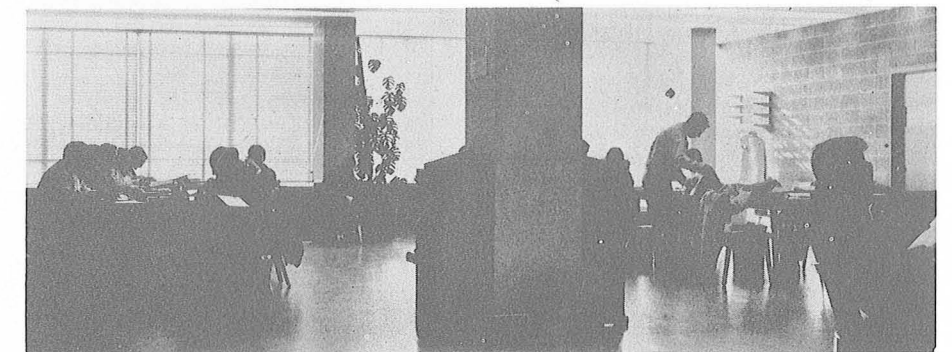

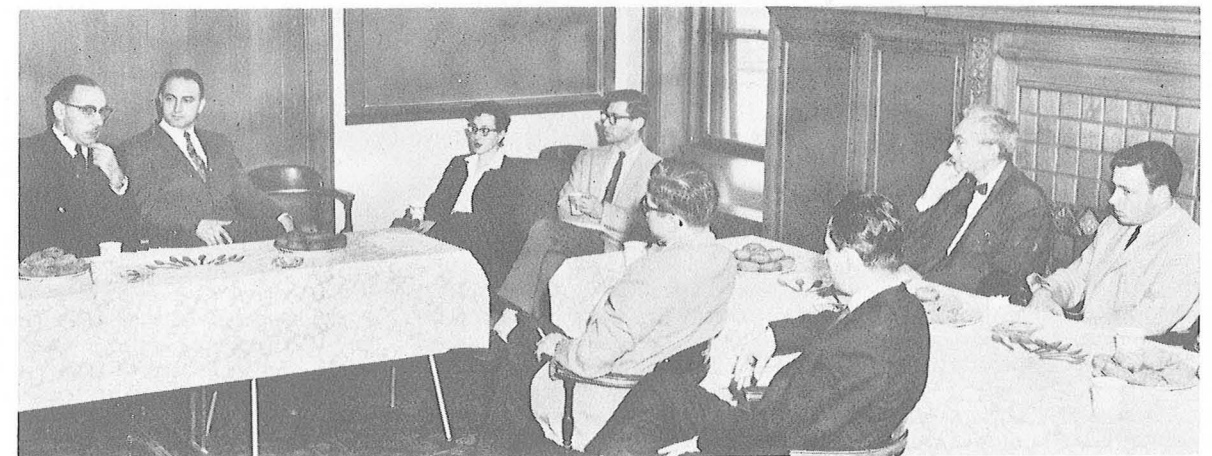

NEWS NOTES

Annual Law Day Is Successful

The Law School's annual Law Day was held Friday, May 10, 1957. The day's program, well attended by the students and faculty, began with a panel discussion in the Kresge Auditorium entitled "Current Problems in Judicial Administration." The panel was moderated by Professor Richard Strichartz and was composed of Professor Sheldon D. Elliott, Director of the Institute of Judicial Administration, and Retired Senior Presiding Judge, Wayne County Circuit Court, Ira W. Jayne. Both Professor Elliott and Judge Jayne expressed the thought that great strides have been taken in improving salaries of judges, efficiency of determination of issues before the courts, and understanding by the Bar of problems facing judicial administration. But, it was also conceded by both that much is yet to be done in these and other areas. The audience had the further pleasure of hearing from Judge Arthur Lederle, Chief Judge of the Federal Court, Eastern District of Michigan. Judge Lederle, a member of the audience responded to questions put by the panel regarding steps being taken in the federal courts to improve the administration of justice.

At 3 p.m., Professor Elliott was guest of the Student Board of Governors at an informal coffee hour. At this time students had the opportunity to personally meet the warm and friendly Professor Elliott and also questioned him regarding the work of his institute, his experiences as a former Dean, and presently as a professor of law.

The evening session of Law Day included a dinner at the Belcrest Hotel, presentation of awards to students for scholastic and activity achievements, and the delivery of the Franklin D. Hepburn Memorial Lecture by Professor Elliott. Mrs. Franklin D. Hepburn was guest of the Law School at the dinner. Dean Arthur Neef served as toastmaster. The program began with words of welcome by Robert Patnales, retiring president of the Student Board of Governors.

Heilbrun, by virtue of his office, was elected as an ex-officio member of the Law School Student Board of Governors. He will serve a one year term.

Keys were also presented to members of the Wayne Law Review, Wayne Law Journal, and the Student Board of Governors.

Professor Elliot's address, entitled "Judicial Selection and Tenure," pointed out the various methods of selecting judicial officers throughout the country. He evaluated the Missouri Plan as contrasted with other methods of selection. He expressed a desire that all jurisdictions adopt a form of judicial selection that will inspire public confidence in the courts. His address will be reprinted in Volume III, No. 3, of the Wayne Law Review.

New Law Faculty Additions Announced

The Dean has announced the appointment of three new faculty members plus the return of a former faculty member. The returning instructor is Dr. Samuel Shuman who has just completed a year of study at Harvard under the auspices of the Rockefeller Foundation. Dr. Shuman formerly taught Equity, Conflicts, and Jurisprudence. He was also faculty adviser to the Law Review.

The new members of the faculty are Professor Benjamin Carlin who will be a visiting professor, Professor Carlin was formerly associated with the Boston University School of Law; Mr. Donald H. Gordon, from Brookline Massachusetts, who has just completed his LL.M. requirements at Harvard and Mr. Lawrence P. King completing his Master of Laws requirements at the U.M.

Law Review Editors Chosen for 1957-1958

The Dean and faculty have announced the selection of the editorial board of the Wayne Law Review for the school year 1957-58. The new board, chosen chiefly on the basis of scholastic and legal writing achievements, is headed by the Editor-in-Chief, Gordon Cutler. Serving with Cutler as Associate Editors will be Thomas Stone, Gordon Meske, and Ashley Gorman. This is the first time in the history of the Review that there are three associate editors. In the past there have been only two. Two of the associate editors will serve as Notes and Comments editors while the third will be in charge of book reviews and leading articles. In addition to the announcement of the new editors, Professor Richard Strichartz, faculty adviser to the Review reported that in the future the Review will feature a section on Recent Trends in Michigan Law.

Outstanding Events In Law School's History

1927
Law School founded. Located on second floor, Old Main. Used Room 211 as principal classroom; library in 208.

1936
Moved to 3rd floor of High School of Commerce Building; occupied rooms on Grand River side of building. Approved by Council on Legal Education of American Bar Association.

1937
First Day Classes started.

1943
Moved back to campus--5063 Cass (the building now houses Radio Department). Total enrollment at one period: 65.

1946
Moved to present quarters at 5229 Cass, then sharing building with School of Public Affairs and Social Work, which later moved into its own quarters. With the great influx of veterans many law classes had to be held in State Hall. One year there were 107 freshmen day students; they occupied 101 State Hall, designed to accommodate 75 comfortably.

1947

Law Library moved into its present new, spacious, and modern quarters in the General Library building. Former library rooms in law building converted into two large classrooms. All classes scheduled in law building.

1954
First issue of Law Review published and favorably received. Doctor of Jurisprudence degree first awarded to graduates with high scholastic achievement.

1957
Entrance requirements raised; higher grade average required for admission. Current enrollment, over 400.

The student Board of Governors recently elected Robert Lawther, Day Junior, to this office. Lawther is also Dean-elect of Delta Theta Phi legal fraternity.
