PLACEMENT

Before this year, the Law School had not formally established any placement program. In the past, requests for graduates have come through the University Placement Office or the office of the dean or members of the faculty. We now feel, however, that it would be helpful to put all of this on a more systematic basis. Accordingly, we will hereafter handle all placements directly from the Law School Placement Office. Mrs. Plihal, director of admissions, will also be director of the placement office with a faculty committee composed of Professors Carlin, Quick, Strichartz and Associate Dean Glavin to give advice and assistance in carrying out the program. Each interested senior student is now asked to fill out a "Placement Service Data Sheet" which will be kept on file in the placement office. In addition we shall try to make the availability of the placement service known to alumni who may be interested in changing positions, particularly the younger alumni.

Your help in letting us know that you are to take on an associate or advising us of an opening in some other law firm or legal department will be greatly appreciated. Only in this way can we be of significant service to the graduates.

We are organizing a placement library so that students now in school may inform themselves as to the opportunities available upon graduation--especially in the fields of corporate and government practice. If you have any materials which you think should be in such a collection, please send them to us.

There is one further way in which you can be of great assistance. We have set up files by geographic areas, both within and without the state, indicating where our alumni are practicing. Your willingness to advise us as to the prospects for younger lawyers coming to your area--and even more importantly, your willingness to discuss the matter with such prospective younger lawyers--would give us the necessary contacts which are now frequently lacking. A card or letter expressing this willingness would be very encouraging.

Law School standards have risen year by year. I believe that a graduate of this school has demonstrated abilities which justify his being considered for a position in your office. All of our students now have intensive work in the basic law skills of legal writing, Moot Court, and practice court.

BUILDING FUND DRIVE

Under the leadership of Benjamin D. Burdick, president of the Law School Alumni Association and a member of the University Board of Governors, a drive is under way to secure the money for the appointment of an architect to prepare

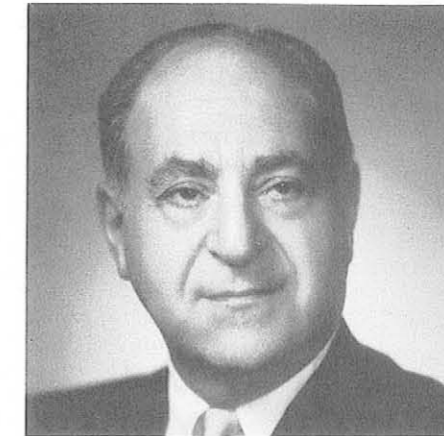

Alumni Reveal Plans for a New School



Governor Benjamin Burdick

"We've outgrown our present facilities long ago," said Mr. Benjamin Burdick in a recent interview. Mr. Burdick is a member of the Board of Governors of Wayne State University and also the President of the Law School Alumni Association. He went on to add, "Here we are on a beautiful campus surrounded by beautiful buildings, and still expecting an antiquated house to serve as our Law School."

Governor Burdick is chairman of a recently formed committee to initiate the plans for a new building for Wayne Law School, a project which ranks high on the priority list of the Board of Governors for facilities to be constructed in the near future. Governor Burdick's committee is striving to raise \$50,000 from alumni contributions to cover the necessary planning expenses. Over \$10,000 has already been pledged and it is hoped that additional alumni contributions will soon swell this amount to the anticipated goal of \$50,000.

The site selected for the new law school is just opposite the McGregor Memorial Building on the corner of Second Avenue and Ferry Street, in the northwest section of the campus. In keeping with the architectural scheme

of the McGregor Memorial Building, the proposed law school building will be similar in design to the recently constructed College of Education.

Governor Burdick cited the new \$4,000,000 law school building at the University of Chicago as an example of what can be achieved through alumni cooperation and initiative. Estimating total costs for Wayne's new law school building at approximately \$2,000,000, Governor Burdick emphasized that widespread alumni interest would not only speed the planning towards the construction of the new law school, but would also demonstrate to the Michigan legislature our great need for more adequate law facilities here at Wayne State University.

The Wayne Law Review

A burst of activity has been seen around the office of the WAYNE LAW REVIEW during the past several months as the twenty-five members of the REVIEW staff busily research cases, check citations, edit articles and perform the myriad functions necessary in the publication of a law review. Now in its seventh year of publication, the REVIEW is no longer a fledgling in a world dominated by giants. By offering leading articles by some of the most prominent legal authorities in the nation, well-researched and well-written student work, enlightening book reviews, and the Annual Survey of Michigan Law, the REVIEW can now compare favorably with many of the most eminent legal publications.

In an effort to add further to the accomplishments of the REVIEW, the editors have recently instituted a number of important developments. Frequency of publication has been increased to four times a year in order to provide much needed additional space for worthy material. Arrangements have been made to publish articles by such renowned authorities as Charles Galvin and Edward Conrad. The Annual Survey of Michigan Law has been expanded

and is being published several months earlier than in the past. Also, plans are now being made to devote an entire issue of the REVIEW to a symposium on an area of law of particular current significance.

Quite properly the primary function of the REVIEW staff lies in the field of scholarly writing. Nonetheless, we must devote some of our attention to the commercial success of our publication. Therefore, it is with a certain measure of pride that we view our rapidly growing circulation. A concerted drive to increase subscriptions was recently undertaken resulting in a twenty-five per cent gain, to a total of 1,600 subscribers. Much of this increase can be credited to the alumni of the Law School who have consistently given fine support to the REVIEW. Of particular interest is the amazing rise in popularity of the Survey issue. In the past two months alone almost 200 new orders have been received for the Survey.

For the remainder of the year our readers can expect a variety of material. A look into the field of oil and gas law, a "new" and important area for Michigan attorneys, will be presented in the Spring issue. The author of this

article is Professor Charles Galvin of Southern Methodist University Law School. Professor Galvin is the taxation editor of the Oil and Gas Law Reporter and has written a number of articles in this field. In light of the many notable developments in the law of evidence, an article in this field written by Professor Edward Conrad of the University of Wisconsin Law School should receive much attention from our readers. Professor Conrad has written a number of treatises on evidence and is a recognized authority on scientific evidence. Also scheduled for publication are comments dealing with such fields as legislative reapportionment, the Michigan law of condemnation, joint bank accounts, and the Michigan Dead Man's Act. Of course, a full complement of case notes will bring our readers up to date on the most recent leading cases.

From its humble beginnings in 1954, the WAYNE LAW REVIEW has enjoyed a rapid rise in prominence. It is our belief that the REVIEW, as a journal of legal thought, has much to offer its readers. Also, as a publication produced solely through student efforts, the REVIEW offers the finest training a law student can receive.

Law School Expands Curriculum

When registration for the spring semester commences, the senior student at the law school will find that he can elect two new and unfamiliar courses of study. These new courses are Comparative Law and Federal Courts. The primary importance of these novel courses is not found exclusively in the fact that they represent a welcome expansion of the law school's curriculum. Of greater significance is that the courses are indicative of the school's rapid progress toward its goal of providing the best legal education possible.

Traditionally, the function and inescapable burden of every professional school is to provide the community with persons prepared to assume the responsibilities of the profession. To a substantial degree, the success enjoyed by a law school in effecting this purpose depends upon the presence of an enlightened faculty and a curriculum which is sensitive to the needs of the profession. Just as the doctrines of case law react to the changing needs of state and nation, so a law school's curriculum will be expanded and modified to meet the demands of the profession.

Examples of this type of expansion of curriculum into new areas of the law are not difficult to find. A typical one is the course in Taxation found at most law schools. As the cost of military security has grown and the Federal and State governments have adopted policies of parenthood toward the citizenry, the need for revenue to support gigantic government has become acute. These governmental attitudes result in ever-increasing tax rates which in turn cause tax problems for the attorney. The law student of fifty years ago rarely dealt with issues of tax law; indeed, the most imaginative of students could hardly have foreseen a massive piece of legislation like the 1954 Internal Revenue Code. Yet the Code does exist and by congressional action assumes greater importance each day. Since issues of tax law have become part of the twentieth century attorney's practice they have also found their way into the twentieth century law student's course of study. In much the same fashion the rise of large scale corporate enterprise has caused the introduction of a course in Corporations in almost every law school in the nation.

Like most institutions of legal education throughout the world, Wayne State University Law School offers a large series of compact courses designed to provide the student with the tool kit he will carry into the field and apply to specific problems. However, the consensus of professional opinion in America has been that the best possible legal education cannot be attained by limiting the student to courses which deal almost exclusively with specific issues or rules. Most educators agree that the law student's academic diet should include courses which have a broader frame of reference. In other words, there is a wide-spread belief that a lawyer will be competent to represent his client only if he is provided with a background in the history of the law, a knowledge of the relationship of law to society, and an understanding of his place in the legal system of which he is a part.

There is no fact clearer today than that the student must be capable of adapting to the legal problems of the future. The state of the law will have a very different complexion twenty or thirty years from now and it is this point in time when today's law student will reach his maximum level of

opportunity. This provides another persuasive reason for offering courses which are not limited merely to a discovery of what the law is on a particular issue. Today's specific answers will not resolve tomorrow's legal questions, but the lawyer with the ability to apply old theory to novel situations will resolve those problems.

It is with these notions in mind that the Law School has in the past presented the student with a course in Jurisprudence and will offer it's new selections in the areas of Comparative Law and Federal Courts.

The course in Comparative Law will be a two credit course taught by Associate Professor, Dr. Norbert West. This instructor is quick to point out the advantages of his course. First, it can be said that the study of Comparative Law will serve to better acquaint the student with his own law. That is, one can not compare the civil law to the common law unless he is familiar with the common law rules. Secondly, the student has much to learn from the other legal systems. Problems which appear to be without solution in our law may become resolvable if we use a technique borrowed from another system of law. Thirdly, as the size of the world becomes smaller in response to advances in transportation, business relations between persons of foreign nations increase so that knowledge of foreign law assumes great importance. Thus, in the study of Comparative Law the student will find some exceedingly practical answers to questions arising in every day practice. Finally, by studying comparative rules of law, the student can begin to make value judgments as to the merit of a specific rule and it's worth to society.

The course will place particular emphasis on the comparison of American Civil Procedure to the Civil Procedure of foreign lands.

According to Dr. West, the Wayne law student is severely handicapped in studying Comparative Law by his lack of familiarity with the languages of other nations. At the present time there is an acute need for English translations of materials which could be used for the study of Comparative Law. As time passes, however, such translations become more abundant.

A stimulating experience for the student who enjoys a course flavored with historical and philosophical material will be the spring semester offering of Mr. Gordon's course in Federal Courts. The course involves an examination of the relationship between Federal and State government and the historical, political, and philosophical aspects of federalism. As you can see, the content of the course is admirably suited to Mr. Gordon's method of instruction.

The terrain covered in the Federal Courts course will not appear directly on the bar examination. As pointed out earlier, the purpose of the course is not to provide a hammer to pound out a specific answer to a client's problem or an examination question, but rather to provide a background which is visible in the actions of the competent attorney.

When measured in terms of the enhanced ability of the Wayne graduate and his better understanding and evaluation of himself and his function as an attorney, these new courses become worth the extra effort and expense involved in their establishment and maintenance as part of the law school's course of study.

"Law School" Doesn't End on Commencement Day

Being a lawyer involves a continuing process of learning. In law school, this learning takes place in a classroom; after law school the lessons are taught in the world of experience. Recognizing that the young lawyer might have difficulty during the transition from classroom to practice, the Institute of Continuing Legal Education was formed to assist the young attorney to bridge this gap. In co-operation with the Detroit Bar Association, it sponsors the Young Lawyers' Seminar, which offers courses for the young attorney designed to initiate him into the practice of law. These courses also help the seasoned practitioner to review as well as to keep up with the recent developments in the law.

The Institute of Continuing Legal Education is jointly sponsored by the University of Michigan Law School and Wayne State University Law School. It is made up of an executive board of three representatives from the University of Michigan and three representatives from Wayne State University. At the present time, the three representatives from Wayne State University are Associate Dean Glavin, Professor Carlin, and Professor Siegel. There is also a full-time director, Professor E. Donald Shapiro of the University of Michigan, and a larger advisory board.

The instructors of the courses prepare extensive written outlines and descriptive materials of the subject matter. This written material is published and will be used again in subsequent courses. Textbooks and written outlines are distributed to all the members of each class.

Courses will be offered in November with meetings on a weekly basis. These courses will be, in general, the same

ones offered at the Young Lawyers' Seminar in April at the University of Michigan. They include Procedure, Real Property Transactions, Contract Relations, Workmen's Compensation, Wills and Estates, Professional Standards of Practice, Criminal Actions, Creditor's Rights, Negligence, and Trial Technique. Also included in the program of the Institute will be the medical-legal courses introduced last year as part of the Adult Education Program. These courses are designed to give the practitioner a working knowledge of the structure and function of the human anatomy, as well as familiarizing him with medical terminology. The courses were devised by Dr. Gilbert E. Corrigan of the Wayne State University College of Medicine, Professor Richard Strichartz of Wayne State University Law School, and Dr. J. Frederic Johnson of Wayne State University College of Medicine. Its overwhelming success is illustrated by its over subscription all three times it was offered. They have now been brought within the scope of the Institute of Continuing Legal Education.

Although in its infancy, the Institute of Continuing Legal Education has already made substantial contributions toward bridging the gap between theory and practice, and its plans foretell of even greater expansion toward this goal in the near future. Because of the efforts of the people who realized the difficulty of the young practitioner, and did something constructive about the problem by forming the Institute of Continuing Legal Education, the young lawyer now can combine both the experience of practice and the classroom method to gain a working knowledge of the practice of law, and no longer must stumble through the complexities of practice on a trial and error basis.

plans and specifications for a new law building. A site has been agreed upon and the capital budget of the University has included the sum of \$2,125,000 for the construction of law school classrooms, offices and library. Mr. Burdick and a number of his colleagues believe that our hopes for this building will be realized many years sooner if we can proceed with the plans and specifications in anticipation of favorable legislative action. I join in this belief, in fact I think this program may be the catalyst for securing this appropriation. You are an influential group. Faculty Notes

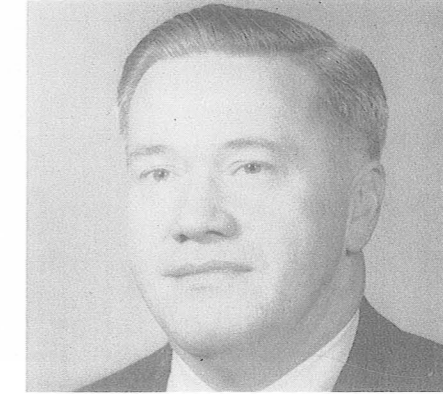
Dr. West has returned from the University of Vienna Law School where he taught comparative law. He will teach a similar course to seniors in the spring semester. ***Mr. Siegel no longer teaches Contracts. In his place is Mr. Boshkoff, sophomore member of the faculty. In addition to his normal offerings of Administrative Law and Labor Law, Mr. Siegel is now handling the course in Conflict of Laws. He is Chairman of the Committee on Legal Education of the State Bar, in addition to his previous assignment as co-chairman of the committee responsible for drafting a statement of Michigan labor law. ***Dr. Shuman is studying jurisprudence in Germany under Rockefeller and Fulbright fellowships and will return in September, 1961. ***Mr. Strichartz has returned from his studies at Yale Law School to resume instructional duties in the areas of agency, commercial paper and corporations. He was studying under a Sterling-Ford Foundation fellowship. ***Mr. Miller has assumed control of a revised procedure course.
