

## **Good Faith Policy to Locate Interviewees of Oral Histories**

The policy of the Reuther Library is to seek oral histories with documentation (i.e., releases/agreements) from donors stipulating that the Reuther has permission to make those oral histories available for research. The above notwithstanding, the Reuther Library realizes that it has and/or will receive oral histories without releases and has determined that it should create a policy for managing such oral histories. That policy is reflected below.

The Reuther Library will not make oral histories with no release available beyond what is allowed in the “fair use” (i.e., [Section 107](#)) clause of the U.S Copyright Act until the interviewees have been deceased for 70 years. In that time frame, the oral histories will not be made available unless the researcher requesting them has signed an agreement indicating that the researcher will not use the oral history beyond what is allowed in the “fair use” (i.e., [Section 107](#)) clause of the U.S. Copyright Act. Similarly, the Reuther Library will abide by provisions found within [Section 108 of the U.S. Copyright Act](#) allowing for the limited reproduction and distribution of copyrighted material within our holdings.

In some instances, a release may not be required. For example, if the oral history was done while in the course of the normal business of the organization with which the interviewee was a member, then those oral histories are to be treated in the same way that the records of that organization would be treated i.e., they would be made available for research pursuant to the terms and conditions outlined in the agreement between the Reuther Library and organization in question.

### **Methods for Conducting a Good Faith Effort for locating the Interviewee:**

In the course of making a good faith effort to locate the interviewee or their heir, archivists will search one or more of the below resources:

- Professional directories
- Standard genealogical reference sources
- Internet searches
- Standard biographical sources
- Alumni associations
- Publishers of authors who are interviewees
- Probate records

- Local historical society collections
- Staff and institutional networks

After the staff of the Reuther have made a good faith effort to locate interviewees, their heirs or relevant copyright holders, the Reuther Library will make a public announcement at least one month prior to the release of any previously restricted oral history, requesting that interviewees, their heirs or copyright holders contact the archives. Once interviewees, their heirs or the copyright holders of oral histories are located, the first objective is to have them sign a release allowing the Reuther Library to make the oral history available to researchers, preferably without restrictions. The Reuther Library will remove oral histories from online access and/or from its holdings at the request of interviewees/heirs/copyright holders where no previously signed release exists.

**Documenting the Effort:**

Whatever method used to locate the interviewee, when those working under the supervision of the Reuther Library are unable to locate the interviewee or her/his heir, Reuther staff will need to document those efforts and retain that documentation in the appropriate case file.
