## History

---

NALC's first convention took place in Boston in 1890 when the union had 52 branches and 4,600 mail carriers. From 1890 to 1903, the union held a convention every year and then began a schedule of biennial conventions, which has lasted to the present day. Although the NALC Constitution has been amended throughout the years, it maintains Article 3 Section 1 that states: The National Convention of this Union shall be held biennially in even-numbered years between the Fourth of July and third full week of August. Convention delegates are elected from every branch throughout the country. While at the convention, they help govern the union by considering amendments to the constitution, discussing crucial matters, and setting national policy for NALC. They can also attend educational sessions while there and can nominate their national officers at every other meeting (every four years).

The NALC Biennial Convention Videotapes Collection consists of recordings of NALC Conventions starting in August of 1984 and ending in July of 2008. In some convention years, recordings were made of the Sunday evening opening program. Those are not counted as "Day 1" of the convention. Day 1 is always Monday, the first day of the proceedings. Some conventions played videos during the proceedings and those videos are included in that year's convention tapes.

Notable speakers at the conventions include: Hillary Clinton, Geraldine Ferraro, Al Gore, and Jerry Lewis.
