The papers of M. A. "Bill" Williams were placed In the Archives of Labor and Urban Affairs In December of 1970 by Mr. Williams and were opened for research In June of 1971. Additional papers were added to the processed collection In June of 1986.

On December 19, 1936, Bill Williams was among the first workers at the Ford Motor Company assembly plant In Richmond, California to join AFL Federated Local 76 which represented workers In various Industries along the Pacific Coast. During 1936 and 1937, there was jursidictional rivalry between workers who wanted to remain In the AFL and those who wanted to join the CIO. In the Spring of 1937, the Richmond workers went on strike. Mr. Williams, who was the Chief Steward, and Frank Slaby, the Local 76 President, helped to organize Local 76 for the CIO. On November 18, 1937, the Ford workers In Richmond and Mllpltas received their own charter as UAW Local 560. In 1941, the NLRB designated UAW Local 560 as the successor to Local 76 when finding Ford Motor Company guilty of unfair labor practices, ordering the company to collectively bargain with Local 560.

Mr. Williams was elected as the first Building Chairman of Local 560 and was a member of Its negotiating committee. In 1946, Mr. Williams was appointed as International Representative for Region 6 of the UAW. He held this position until 1948 when he returned to Local 560 as Building Chairman, a post he held until about 1967.
