The papers of William W. Betts were placed in the Archives of Labor History and Urban Affairs in June of 1972 by Mrs. Jessie Betts.

William Betts was born in Wilmington, North Carolina on May 24, 1917. After being graduated from Dallas Aviation School and Air College, Love Field, in 1935, he flew as a co-pilot and then a captain for Braniff Airlines; he received a diploma from the University of Southern California's Institute of Aerospace Safety. He was a leading figure in the Airline Pilots Associations, (ALPA), serving as Central Air Safety Chairman for Braniff and as Chairman of the Fourth Region Air Safety Committee. In those capacities, he participated in many important projects for ALPA such as the SST Boeing Committee, BAC 1-11 Evaluation, (making several trips to Britain and France), Crew Complement-BAC 1-11, Tall Buildings Dallas, Pilot Protective Provisions Committee ALPA 1958, besides serving on each Accident Investigation team Braniff/ALPA. Mr. Betts was well known for his conscientious attention to all information pertinent to the cases and his expert knowledge of all facets of aviation. Also, he served as a consultant assisting in many cases for the ALPA legal counsel in FAA/Pilot Hearings of violations. Mr. Betts died in Dallas in May of 1971 of leukemia, after many years of service working for air safety.

The papers of Mr. Betts reflect his work with Braniff and ALPA, especially his efforts as the Central Air Safety Chairman for Braniff.
