The papers of Philip Booth were placed in the Archives of Labor History and Urban Affairs in January, 1976 and were opened for research in September, 1976.

Philip Booth was active in the founding of the United Federal Worker's Association - Local 10 during the 1930s. He was an employee of the Federal Security Agency at that time. Mr. Booth also participated in the Hunger March on Washington, D.C. in 1932.

Three other collections held by the Archives of Labor History and Urban Affairs are related to the 1932 Hunger March. Those collections are: Alex Baskin, Joseph Brown, and Henry Kraus.
