The papers of Douglas Alan Strachan were placed in the Archives of Labor and Urban Affairs in October 1981 by Mr. Strachan, and were opened for research in October 1983.

D. Alan Strachan was born in London, England, on August 6, 1903. He attended technical schools there and completed the equivalent of three years of high school before emigrating to the United States in 1926. He became a naturalized citizen in 1933. Mr. Strachan worked for a Detroit toolmaker until 1937, and was an official for the CIO and an international representative for the UAW from 1936 through 1943. From 1943 to 1945 he was a Deputy Vice-chairman of the War Production Board in Washington, D.C. He returned to the UAW in 1945 to serve as its Washington representative for two years. The remainder of his career was spent in government.

From 1947 to 1953 Mr. Strachan was a labor advisor to the U.S. Economic Mission in Greece, an agency that eventually became the Agency for International Development (AID). He was transferred back to Washington in 1954, where he worked in various capacities for AID until 1959 when he was sent as its Regional Director to West Pakistan. At the end of that tour he was appointed Deputy Director for the AID program in Cairo, 1962 to 1964, and then went briefly to Vietnam in 1965. In 1966 he was named Director of the Colombo Plan Bureau in Ceylon, where he stayed until 1969. His last career post was again in Washington, D.C. as Chief of the Welfare and Grievance Staff for AID, from 1969 to 1973. Mr. Strachan retired in June 1973, and in 1983 was still living in the Washington area.

The papers in this collection reflect Mr. Strachan's interest in the labor movement, both here and abroad, and the various political and personal aspects of his career in government. Important subjects covered in this collection are:
