The papers of the UAW-GM Department were deposited with the Labor History Archives ca 1962-1963.

The origin of the UAW General Motors Department can be traced to a conference of General Motors delegates representing from 15 to 50 General Motors plants. This conference was called by the International Union and convened in Detroit on June 5 and 6, 1937. The delegates elected a committee of seventeen members who were authorized to draw up a proposed contract with General Motors. This committee was the forerunner of the General Motors Department which was established ca. May 1938. Its first director was William E. Dowell who held this position for one year. In the spring of 1939, Walter Reuther took charge of the Department which he directed for six years until he was elected president of the UAW in the fall of 1946. Leonard Woodcock is the present director.

The UAW-GM Collection covers the period from 1938-1964.
