The papers of UAW Local 32 were placed in the Archives of Labor & Urban Affairs in 1978 by vote of the membership.

Local 32 represents employees of the White Motor Company in Cleveland, Ohio. The charter meeting was held on August 25, 1933 when it became Federal Labor Union 18463 affiliated with the AFL. The local played an early and important role in the establishment of an international union in the automobile industry. In September, 1935 formal application was made for charter affiliation with the International Union of United Automobile Workers of America.

Wyndham Mortimer and Richard E. Reisinger were two early leaders of the White Motor Company Local who rose to higher positions in the International. Wyndham Mortimer was a powerful force in the establishment of the UAW and was elected first vice president in 1936. Reisinger became Regional Director of the UAW-CIO Region 2 in 1937.

In addition to the material in this collection, partially complete series of the local's newspaper,  $\underline{\text{Right}}$   $\underline{\text{Angle}}$  and the company's paper,  $\underline{\text{The}}$   $\underline{\text{Sandbag}}$ , are held in the Archives.
