The papers of Samuel Jacobs and Paul Sifton of the United Automobile Workers' Washington Office Legislative Department were placed in the Archives of Labor and Urban Affairs in 1966, 1968 and 1971.

The Legislative Department of the Washington Office was created shortly after the union's 1947 convention. Its primary responsibility, under the leadership of Donald Montgomery, was to direct the legislative lobbying activities of the United Automobile Workers Union.

Before joining the Washington Office staff as a legislative representative in 1948, Paul Sifton held a variety of jobs as a labor reporter, an administrator with government agencies and as a legislative representative with the National Farm Workers Union and other non-profit organizations. In 1957 he took over operation of the department from Donald Montgomery and remained in that position until December of 1962, when the Washington Office was abolished and the Legislative Department became part of the Citizenship-Legislative Department under the direction of Roy Reuther. Mr. Sifton retired from the UAW in 1963.

Samuel Jacobs was born in 1910. After receiving B.S. and M.A. degrees from Wayne University, he taught in the Detroit Public Schools (1928-1941). After working for the Office of Price Administration as consumer representative for the Detroit District and the CIO's representative on its Labor Policy Committee, he joined the staff of the United Automobile Workers Washington Office as a representative with the Legislative Department in 1948. From 1951 to 1953, he represented the union on the Consumer Advisory Committee of the Office of Wage Stabilization. He remained with the Legislative Department until his death in December, 1959.
