Scope and Content:

The materials in this collection cover the span of Douglas A. Fraser's presidency of the UAW from 1977-1983. The records are arranged into three series: Series I: International Executive Board, Series II: Collective Bargaining, and Series III: Correspondence. Series I covers the proceedings of the International Executive Board (IEB) of the United Auto Workers. Included within this series are correspondence with regional directors, meeting materials, and IEB resolutions. Series II covers collective bargaining with the Big Three auto companies. Series III contains correspondence from the President's office between union members, big three executives, and the general public. Materials include correspondence, clippings, and reports.
