# History

The Labor and Working-Class History Association, also known as LAWCHA, was created on October 17, 1998 and was incorporated December 14, 1999. Before and during the 1997 North American Labor History Conference (NALHC), the idea of creating such an organization arose and at the next conference LAWCHA came to be. The organization was started to support work done in the field of labor and get more attention and recognition of the topic. Some ways they do this is to provide research and travel grants to graduate students, participate in conferences held by other organizations, and award prizes

for scholarship. When LAWCHA began, leaders were put in place until 1999 when members, through an election by post, chose officers and board members. Along with the officers and board members, there are a number of committees that help run the organization. The organization's headquarters was first at Wayne State University and after that was at the Carnegie Mellon University in Pittsburgh, Pennsylvania, where they were assisted by the Center for African American Urban Studies and the Economy (CAUSE). Now they are located on Duke University's campus in Durham, North Carolina. In the beginning, the annual meetings of LAWCHA were held during NALHC. This continued until 2007 when the organization started moving the meetings to different conferences.

## **Scope and Content**

The records in this collection are from Thomas Klug, the Treasurer of LAWCHA for many, and appear to also be from Joe Trotter, a former president, and Robin Dearmon Jenkins, a former Executive Secretary. The collection heavily covers the first few years of the organization, but does have materials that go to 2016. Topics covered include the founding and early history of LAWCHA, election of officers and board members, Board of Directors, Executive Committee and other committees, finances, membership, awards and grants, and incorporation. Items in the collection include: correspondence, agreements, meeting and conference materials, reports, brochures and flyers, newsletters, and election materials.
