Abstract: Tracy W. McGregor and Katherine Whitney McGregor

established the McGregor Fund in 1925 to ensure that their financial resources would continue to be used for social, educational, and charitable programs. Both of the McGregors were lifelong philanthropists, with Tracy heading a mission for the homeless from 1891 to 1936 and Katherine volunteering at numerous organizations, establishing an orphanage and facility for the aid of young mothers, and donating extensively to a number of local charities. They established the McGregor Fund to act as a grant-making organization with priorities including higher education, youth services, health care and science. This collection consists of legal, administrative, and financial papers of the McGregor Fund, including deeds of gift that established the Fund; bylaws, articles and amendments, board of trustee minutes; annual reports; and information on its projects and grants. There is biographical information relating to Tracy McGregor in particular, the McGregor family more broadly, and other prominent Detroit philanthropists. Two series cover the establishment and history of the McGregor Library at the University of Virginia and the McGregor Memorial Conference Center at Wayne State University, including photographs. Also included are photographs relating to Tracy McGregor, his associates, family, and the McGregor Fund board of trustees.

History

Tracy W. McGregor (1869-1936) and Katherine Whitney McGregor (1873-1954) established the McGregor Fund in 1925 to ensure that their financial resources would continue to be used for social, educational, and charitable programs. Both of the McGregors were lifelong philanthropists, with Tracy heading a mission for the homeless in Detroit from 1891 to 1936 and Katherine volunteering at numerous Detroit organizations, establishing an orphanage and facility for the aid of young mothers, and donating extensively to a number of local charities. They established the McGregor Fund in 1925 to act as a grant-making organization with priorities including higher education, youth services, health care and science. During his lifetime, Tracy McGregor was involved in numerous social service organizations, including Provident Loan and Savings Society, the Detroit Community Fund, the Wayne Country Training School and the Merrill Palmer Institute, to name just a few. He also helped establish and administer scholarly organizations such as the Clements Library at the University of Michigan and the McGregor Library at the University of Virginia. Katherin McGregor and the McGregor Fund Trustees continuted and expanded his work after his death. The McGregors' legacy continues into the 21st century as the McGregor Fund provides "financial assistance to nonprofit emergency human service agencies and health care programs, especially for lowincome individuals and innovative educational and cultural initiatives." Scope and Content

This collection consists of legal, administrative, and financial records of the McGregor Fund, including deeds of gift that established the Fund; bylaws, articles and amendments, board of trustee minutes and committee reports; annual reports; and information on projects and grants. There is biographical information relating to Tracy McGregor in particular, the McGregor family more broadly, and other prominent Detroit philanthropists. Two series (4 and 5) cover the establishment and history of the McGregor Library at the University of Virginia and the McGregor Memorial Conference Center at Wayne State University, including photographs.

One series (6) comprises research material collected by Philip P. Mason for his biography of Tracy W. McGregor. Also included are photographs relating to Tracy McGregor, his associates, family, and the McGregor Fund board of trustees. A McGregor Fund scrapbook dated 1928 to 1935 (in fragile condition) is part of the collection.
