Abstract

This collection holds publications produced by the Law School of Wayne University and Wayne State University. *The Gavel*, first published by the Student Bar Association of Wayne University in 1952, became *The Wayne Law Journal* in 1953 when taken over by the Wayne University Law School. When Wayne University became Wayne State University in 1956, the journal's name was changed to *The Wayne State Law Journal*; in 1962, it became *The Wayne Advocate*. This journal ended regular publication with Volume XI in 1963, with the exception of an annual Commencement issue. A new series, *The Wayne Advocate: Tabloid Edition*, began publication in 1967, and continued until 1969. This was replaced by *Chamber Notes*, of which only two issues were produced, in 1969 and 1970, and *Law School Newsletter*, of which only one issue was published, in 1973. During this time (1968-1974) the law school also produced an unrelated publication, the *Newsletter*. From 1975 until 1980, the Law School published the newsletter *Nexus*. In 1980 the magazine *The Wayne Lawyer* began publication.
