

Deans Message

The title of this issue is Commencement 1965—and this is indeed a year when that title has exceptional significance. This will be the first commencement at which all seniors who have had their bachelor's degree will receive the degree of Juris Doctor. For all who will be graduated in June it is the commencement of a career, and we congratulate them and wish each of them great success.

Although graduates are greater in number and their abilities may be higher



than in prior years, this is not what makes this particular year exceptional. It is the start of construction on the law library and classroom buildings that marks a new beginning for the Law School. Over the years since 1927 the law library has moved from Old Main to Commerce High School, to 5063 Cass (across from Mackenzie Hall), then to what is now Room 11 of our present building, and finally to its location as a separate section of the University Library. Our offices and classrooms have gone through similar moves. When the buildings now under construction are completed next year, we will have a legal center which will permit the necessary growth in student body and faculty, and which will provide a dignified and efficient setting for a legal education. Even for those who this year leave us, and for those students who must suffer the present inadequacies for another year, there still will be the feeling of pride in the enhanced position in the University and the community which will result from these developments.

From the Alumni Association . . .

As the Law School looks forward to the eventful occasion of moving into a new and beautiful building, it is probably not amiss to say a few words about the Law Alumni Association.

The Association began to operate effectively from the time of its reactivation in 1950. Since then the Association has enlisted 1,337 members of a total of 2,043 graduates.

Membership in the Association is a lifetime membership, achieved by the payment of the modest sum of \$1,00. The annual operation of the Association is financed by the generosity of its members who pay annual sustaining dues in the amount of \$2,00 or more. It is of interest to note that in 1964, 743 members paid sustaining dues totalling \$1,511.

The Association is managed by a Board of Governors which now consists of 22. Five new board members are added each year and past presidents are automatically members of the Board of Governors. Any member of the Association may propose his own name or that of any other person for membership on the Board of Governors.

The Association has devoted itself to advancing the cause and status of the Law School and its students. For a number of years the Association has made awards to outstanding students. One of these is the Law Alumni Moot Court Competition prize of \$200, which is divided among the law students who are the finalists in the Law School Moot Court competition. The Association also helps the student body finance special activities and provides information on employment opportunities to the Law School Placement Office.

Annually, the Association, in cooperation with the Law School, presents a Law Alumni Day, on which occasion alumni come back to the Law School to enjoy good fellowship and a worthwhile program. In 1965 the Law Alumni Day was held on March 20, and the subject for discussion was, "Implementing Gideon v. Wainwright in Michigan: Some Problems."

Panelists for the 1965 Law Alumni Day were: The Hon, Robert B, Burns, Judge, Michigan Court of Appeals, Chairman; The Hon, Timothy C. Quinn, Judge, Michigan Court of Appeals; Samuel J. Torina, Assistant Presecuting Attorney, Wayne County; Lionel H. Frankel, Associate Professor of Law at Wayne State University; Sheldon P. Otis, member of the Detroit Bar; and William Madden, Assistant Director, National Legal Aid and Defender Association.

The presentations were effective, penetrating and sometimes in conflict. The discussion was critical and invigorating. The entire day was especially gratifying since it concluded with the ground-breaking ceremonies for the new law building.


